- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The wetland within the review area, shown on the attached map, is isolated and is not considered a Water of the US. The WDNR identified the wetland in the review area. It appears the wetland developed in an area excavated for recreational purposes (ball field). Aerial photos and roadside photos indicate the wetland is a depressional feature in a developed area that does not have a surface or subsurface connection to any other water. Topographic maps do not indicate drainage to another water. The wetland does not border, is not neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes or berms. The wetlands offer little to no habitat function as it is manicured grass. There is no ecological connection to other wetlands or waters as the wetland is surrounded by development. The aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetland 1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
