The ditched portions of the waterbodies identified in column 1 were constructed to convey run-off from the adjacent roadway. They were constructed in upland and are now linear wetlands. They are not (a)(1) waters, they were not constructed in a tributary, do not relocate a tributary, and were not constructed in an adjacent wetland. This was confirmed by reviewing Lidar imagery, the National Hydrography Dataset (NHD), historic and current aerial imagery, and National Wetland Inventory (NWI) and Soils mapping for the project site. State and local regulatory staff conducted a site visit and confirmed that all of the ditch features listed in column 1 were constructed in and are surrounded by upland
