D. ADDITIONAL COMMENTS TO SUPPORT JD: The review area for the delienation completed on this property included contains ten wetland basins and 5 watercourses. This approved jurisdictional determination (AJD) is specific to the northern portion of the watercourse labeled as WC-02, outlined in orange and described on the enclosed figures and tables labeled 2019-02510-MMJ Kelzer Delineation and AJD Figures 1-4. The northern portion of WC-02 is a ditch feature that spans approximately 500 linear feet on the northeastern portion of the Kelzer property. The ditch feature has intermittent flow, is approximately 4-6 feet wide at top of bank, and has a channel bed that is approximately 1-2 feet wide. Historic aerials indicate that the northern portion of WC-02 is a constructed feature. It is currently bordered by upland crop land. It is not a relocated tributary or excavated tributary, and it is not currently draining a wetland. Therefore, this aquatic resource is an excluded feature as described in part (b)(3)(ii) of the 2015 Clean Water Rule (CWR), and it is not a jurisdictional water of the U.S. This was confirmed by reviewing current and historic aerial photography, national hydrography data, numerous topographic maps, and the wetland delineation report that was completed for this project site. Based on this review, the northern approximately 500 linear foot portion of WC-02 is not jurisdictional under the 2015 Clean Water Rule.

¹ In many cases these excluded features will not be specifically identified on the approved JD form, unless specifically requested. Corps Districts may, in case-by-case instances, choose to identify some or all of these features within the review area.
