2020-00913-EJW Pages 1 of 3 through Page 3 of 3. The nearest a(3) water is Lake Wakanda located approximately 2,150 feet to the northwest.

A thorough desktop review was conducted with historic and current aerial imagery to determine if the unnamed ditch was a relocated tributary, but it was present in the earliest found aerial imagery (1938). There is no evidence that at the time the ditch was originally constructed, the ditch did not relocate a tributary, was not constructed in a tributary, or was not constructed in an adjacent wetland. The unnamed ditch is a manmade agricultural ditch that was constructed in uplands. The unnamed ditch is a perennial ditch that is not an (a)(1) or (a)(2) water.

Based upon information gathered as a result of the desktop review, Corps staff determined that the unnamed ditch is a manmade ditch that was constructed in uplands. The unnamed ditch should be excluded using the (b)(5) exclusion under the Navigable Water Protection Rule and is thereby determined not to be jurisdictional under the Clean Water Act.
