W-1	0.97	acre(s)	(b)(1) Non-adjacent wetland.	<p>W-1 is a wet meadow depression surrounded on all sides by upland, evidenced by aerial photos showing lack of wet signatures, soils maps showing non-hydric or predominately non-hydric soils to the west, south, and east, contours showing steeper slopes to the east and south, and a lack of Wisconsin Wetland Inventory polygons. The wetland is also constrained by the distribution center to the west. The west edge of the wetland abuts the distribution center's access road, but there is no culvert structure connecting the wetland to the other side of the road. Based on the delineation report and aerial photos, other than one underground storm inlet there are no culvert inlets/outlets other than overland sheet flow.</p> <p>The closest tributary is the Rock River, approximately 1,900 feet to the west and over 20 feet lower in elevation. Based on FEMA's National Flood Hazard Layer, W-1 is in the Area of Minimal Flood Hazard; therefore, it would not be flooded by an (a)(1)-(a)(3) water in a typical year.</p> <p>Topographic contours and aerial photographs show that W-1 is not separated by an artificial or natural barrier from an (a)(1)-(a)(3) water.</p>
W-2	0.05	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	<p>W-2 is a pond used to store stormwater that was constructed during 2015/2016, as shown by aerial photos, ground level photos, and the Heartland delineation report. The pond was constructed in upland because most of the pond is located in non-hydric soil (as shown on soils map) and the site does not exhibit wet signatures in aerial photo years prior to construction.</p>
