


D. ADDITIONAL COMMENTS TO SUPPORT JD: The review area includes an erosional feature and the upper portion of a grassed waterway that appears in an agricultural field. As observed in aerial photos taken in 1991, 2003, 2004, 2006, 2008, 2009, 2010, 2011, and 2015, the erosional feature and grassed waterway are present and farming activity was continued across the features with little to no interuption. No surface water is observed in any of the aerial photos. USGS and NHD data do not identify any surface water features in the review area. No wetlands are identified in the review area. A site photos taken on June 10, 2019, of the review area, confirms the presence of a grassed waterway in the agricultural field and farming activity continuing through the area of the erosional feature. The erosional feature is limited to minor patterns at the soil surface in the site visit photos. A defined bed and bank is not present. Site visit photos confirm that no OHWM is present.


