A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

B. CWA SECTION 404 DETERMINATION OF JURISDICTION.

There are no"waters of the U.S." within Clean Water Act (CWA) jurisdiction (as defined by 33 CFR part 328) in the review area.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area contains three wetlands, labeled W-1 (0.10 acre), W-2 (0.50 acre), and W-4 (0.01 acre). All three wetlands are isolated, per review of a September 2021 wetland delineation report by Kapur, a May 2016 wetland delineation report by Kapur, and a 2021 wetland delineation exemption request by Kapur. These documents included USGS topography, NRCS hydric soils maps, Wisconsin Wetland Inventory maps, proposed site development plan, narrative of site history, historic aerial photos, and ground level site photos. The boundary of Wetland 2 was updated (expanded) after WI DNR review and is now described as a "mosaic" of wetland. The wetlands all appear to have been created sometime after abandonment of the Lake Geneva Speedway motocross trails around 2006. The site has been abandonded since 2006; therefore, the wetlands are being reviewed as isolated. There are no inlets/outlets or other surface or shallow subsurface connections to a downstream waterbody associated with any of the three wetlands. Wetland 2 extends to the north side of N. Bloomfield Road, but there is no culvert that would convey flow from Wetland 2 south of the road. The nearest tributary is unnamed to Geneva Lake, approximately 0.5 mile to the east of Wetland 2.

Wetlands 1, 2, and 4 do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes, or berms. Due to existing and surrounding land use (heavily disturbed trail system and agricultural fields) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetlands 1, 2, and 4 are not regulated by the Corps under Section 404 of the Clean Water Act.
