Explain: **The review area consists of five wetlands- W2 (0.10 acres), W3 (1.76 ac), W4 (0.02 ac), W6 (0.12 ac), and W7 (0.18 ac). Based on the January 2020 Wetland and Waterway Delineation Report by TRC, these features are fresh wet meadow and farmed wetlands. All of the wetlands are isolated, per review of the January 2020 report, which included a 2 foot contour topographic map, NRCS soils map, Wisconsin Wetland Inventory, FSA crop slides, Google Earth aerial photography, and ground level site photographs. All of the wetlands were reviewed for inlet/outlet structures; none were observed. W6 is connected to a wetland offsite that was previously determined to be non-jurisdictional (2018-01127-ANM).**

**These wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (residential and agricultural development) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that wetlands 2, 3, 4, 6, and 7 are not regulated by the Corps under Section 404 of the Clean Water Act.**
