- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The review area includes a parcel measuring approximately 74 acres located southwest of the intersection of County Road 11 and US Highway 52. The site has historically been used as cultivated cropland and currently consists of cultivated cropland. The National Wetlands Inventory (NWI) indicates no wetland areas as being mapped within the survey area and the MN DNR Public Waters Inventory Map does not indicate any waters within the review area. The National Hydrography Dataset (NHD) indicated the presence of an intermittent stream. The applicant completed an onsite assessment in which a stream channel with a defined bed and bank was not observed. In addition, no indicators of wetland hydrology were observed at sample points. The Filmore County Soil Survey indicates lack of hydric soils in the review area.
