Wetland 1	36.70	acre(s)	(b)(1) Non-adjacent wetland.	The nearest a(2) water is Golden Lake, approximately 2.2 miles to the southeast of the review area. Wetland 1 is a large wetland that extends off site and is adjacent to Anoka County Ditch (ACD) 62. The ditch flows east and then south prior to draining into Golden Lake. In addition, four previously approved jurisdictional determinations (AJD) were finalized in June and August of 2020 and January 2021 that excluded ACD 62/ACD 53-62 due to the ditch being constructed in non-adjacent wetlands. Additionally, the ditch is not a natural feature, a relocated tributary, or constructed in a tributary (see Section III. C.). Therefore, Wetland 1 is not a water of the U.S. due to the lack of adjacency to an a(1)-a(3) water.

C. Additional comments to support AJD: A USGS topographic map from 1902 does not show the same alignment of ACD 62 as it appears currently along the review area. However, historic aerial imagery from 1938 displays ACD 62 as it currently appears in recent Google Earth imagery as does USGS topographic maps from 1955. The ditch was likely relocated sometime between 1902 and 1938 in non-adjacent wetland in this segment of the ditch. Four previously approved jurisdictional determination (AJD), finalized in June 2020, August 2020, and January 2021 under the Navigable Waters Protection Rule, excluded ACD 62 and a downstream ditch (ACD 53-62) that ACD 62 confluences with. Specifically, the areas reviewed for MVP-2020-01086-DCR and MVP-2020-02069-SSC are adjacent parcels and within the same wetland complex as Wetland 1. The ditches are the only surface water outlets for the wetlands within the review area. Since they are not jurisdictional tributaries the wetlands are not adjacent and are not waters of the U.S.
