Explain: **The review area for this jurisdictional determination includes fifteen roadside ditches labeled as Wetland Ditch #1-15 on the attached figure labeled as 2022-01924-TJH Figures 1-11. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330) and the 2008 Rapanos guidance, the Corps does not generally consider the following features to be waters of the United States; non-tidal drainage and irrigation ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States. According to the wetland delineation report submitted by Widseth, fifteen linear ditches were within the review area. These features do not convert relatively permanent flow (as seen in Figures 2-11), were constructed wholly in uplands, and drain only in uplands (based on delineation report). Therefore, Wetland Ditches 1-15 (0.03 acre), as shown in the attached figures are not waters of the U.S.**
