Wetland 1	0.005	acre(s)	(b)(1) Non-adjacent wetland.	<p>Based on a review of aerial photography, site photos presented in the wetland delineation report, USGS Topo Maps, and the Wisconsin Wetland Inventory Mapping, we have determined that Wetland 1 is an isolated feature whose boundaries do not extend outside the review area and does not have a hydrologic connection to a downstream WOUS. A review of available topographic mapping shows an elevation difference of 97 feet between Wetland 1 and the nearest a(1)-a(3) waters, Shawano Lake, eliminating the likelihood that this feature would be flooded in a typical year by an a(1)-a(3) water. In addition, aerial photography does not show any wet signatures around Wetland 1, potentially connecting this feature to an a(1)-a(3) water. Therefore, we have determined that Wetland 1 is completely surrounded by uplands.</p> <p>Based on this information, Wetland 1 does not abut an a(1)-a(3) water and is not separated by one from a natural or man-made feature and we have determined that Wetland 1 is a (b)(1) non-adjacent wetland, which is not subject to regulation under Section 404 of the Clean Water Act.</p>
