Wetlands 1 and 2	0.99	acre(s)	(b)(1) Non- adjacent wetland.	Based on a review of aerial and ground level photos provided in the delineation report, both wetlands are present in the bottom of a swale feature traversing through the review area from the southwest corner to the northeast. Both wetlands are surrounded by uplands involving mostly forested areas, agricultural fields to the west and north, residential development involving a driveway separating the two wetlands in the central portion of the review area, and paved roadways to the east and south. The delineation map shows the boundaries of Wetland 1 extends outside of the review area to the north. The Wisconsin Surface Water Data Viewer indicates an (a)(1)-(a)(3) water, an unnamed tributary, is located approximately 0.26 mile further north of the review area. A topographic map provided by Winnebago County GIS shows a decrease in topography from 818 at Wetland 1 to 798 near the unnamed tributary. Additionally, aerial photos provided via Google Earth demonstrates the wetland extends to the north approximately 0.18 mile where it is then contained by uplands involving residential development. The delineation map also shows the boundaries of Wetland 2 extends outside of the review area to the southwest. The Wisconsin Surface Water Data Viewer shows a second (a)(1)-(a)(3) water, another unnamed tributary, approximately 0.22 mile southeast of the southernmost point of Wetland 2 within the review area. A topographic map (previously mentioned) displays an elevation of 824 at Wetland 2 that decreases to 822 towards the tributary. A review of historical aerial photos provided in the delineation report and via Google Earth (photos taken 05/2018, 04/2017, 04/2015, 05/2011, 06/2010, 06/2008, 06/2006, 05/2005, and 05/1992) primarily taken during the wetter months of the year, illustrate mostly dry conditions throughout the review area. Further review of aerial photos provided by Google Earth

			suggest a culvert may be present in the central portion of the review area connecting Wetlands 1 and 2 under the residential driveway. A review of floodplain maps provided via the Wisconsin Surface Water Data Viewer indicates no mapped floodplains are present for either the tributary to the north or the tributary to the south. The distance from the tributaries to these wetlands, the change in elevation, the lack of a mapped floodplain within the review area, and aerial and ground level photography, all indicate these wetlands do not abut the tributaries to the north and southeast, are not separated from these waters by natural or man-made barriers, and do not receive flooding in a typical year from these waters of the U.S. Therefore, Wetlands 1 and 2 are (b)(1) Non-adjacent wetlands which are non- jurisdictional under Section 404 of the Clean Water Act.
