Based on the submitted delineation report and aerial and historic photography, we have determined these wetland features are ditches that were constructed in uplands within the ROW of County Road DDD. The areas where Wetland 3, 4, 6, and 7 were constructed lacked wet soil indicators and sufficient hydrology to support wetland conditions, and are not part of a relocated tributary. Therefore, these wetlands were constructed in uplands. The soil series (OsA) is a predominantly non-hydric soil series and based on the topography and geometry of the road, the boundaries of these features transition into upland areas within the review area and are confined to the toe slope of the constructed ditch. Based on the information stated above, we have determined that Wetlands 3,4,6,&7 are (b)(5) exclusion waters and are therefore not regulated by the Corps of Engineers under Section 404 of the Clean Water Act.
