The Contour Map submitted in the wetland delineation report indicates that Wetlands WB-01, WB-02, WB-03, WB-04, and WB-05 are depressional basins, completely surrounded by uplands. This was confirmed using Google Earth imagery from 1985, 1991, 2002-2006, and 2008-2020. Ariel imagery also showed no tributaries in the vicinity of Wetlands WB-01, WB-02, WB-03, WB-04, and WB-05. The closest tributary is approximately 400 feet east of WB-04 and is separated from the wetland by a driveway and residential development areas. Wetlands WB-01, WB-02, WB-03, WB-04, and WB-05 do not share a surface water connection with an a(1)-a(3) water. Therefore, Wetlands WB-01, WB-02, WB-03, WB-04, and WB-05 are not considered waters of the U.S. under the Navigable Waters Protection Rule.
