MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the “Revised Definition of ‘Waters of the United States’”; (88 FR 3004 (January 18, 2023) as amended by the “Revised Definition of ‘Waters of the United States’; Conforming” (8 September 2023) ,¹ MVP-2009-01374-ALH [MFR 1 of 1]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army (“the agencies”) published the “Revised Definition of ‘Waters of the United States,’” 88 FR 3004 (January 18, 2023) (“2023 Rule”). On September 8, 2023, the agencies published the “Revised Definition of ‘Waters of the United States’; Conforming”, which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) (“*Sackett*”).

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

Wetland 5 (W-5) is a depressionnal farmed wet meadow wetland that is completely in the delineated area surrounded by uplands based on the delineation report. The National Wetland Inventory layer does not indicate wetland presence where W-5 is located. The USA Soils Hydric class is not hydric.

Wetland 4 (W-4) is a farmed wet meadow wetland that may extend outside of the delineated area. There is a subdivision development immediately to the south of W-4, immediately to the east of W-4 is a portion of an agricultural field, and then even further east is another subdivision development. The National Wetland Inventory layer does not indicate wetland presence where W-4 is located. The Digital Elevation Model and Hillshade layers of the National Regulatory Viewer show that W-4 may drain to the east toward a low point in the existing subdivision outside of the delineated area but does not indicate that the wetland directly abuts a relatively permanent water.

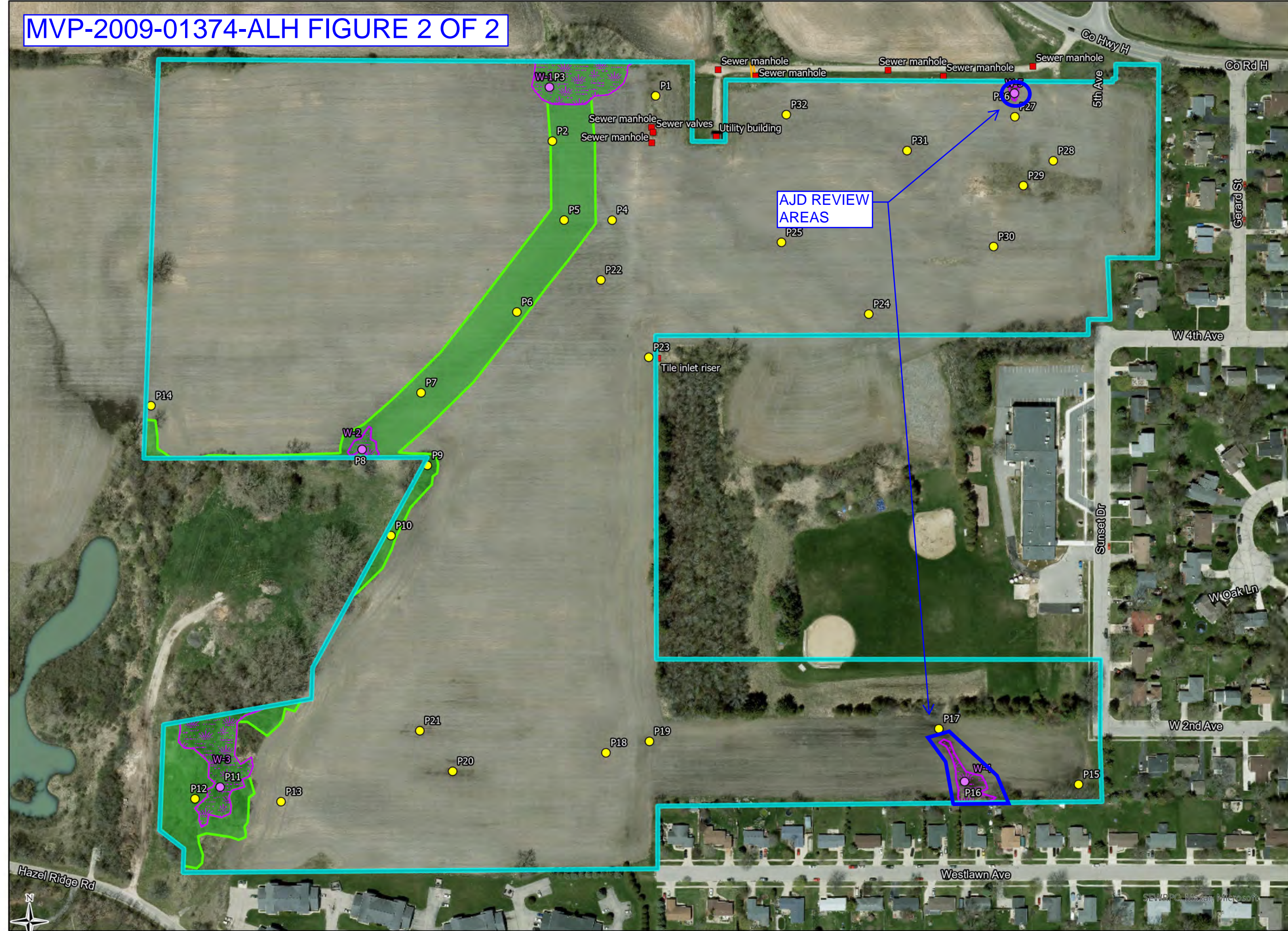
The wetlands are not TNWs, territorial seas, or interstate waters and therefore are not (a)(1) waters. The wetlands do not extend to any tributaries. The wetlands do not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary. The wetlands are non-tidal wetlands that are not abutting a relatively permanent jurisdictional water and as such do not meet the definition of adjacent and cannot be evaluated as (a)(4) adjacent wetlands; therefore, the wetlands described above are not jurisdictional under the 2023 Revised Definition of Waters of the United States’; Conforming” 88 FR 61964 Final Rule.
