MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the “Revised Definition of ‘Waters of the United States’”; (88 FR 3004 (January 18, 2023) as amended by the “Revised Definition of ‘Waters of the United States’; Conforming” (8 September 2023) ,¹ MVP-2011-04539-JLK [MFR 1 of 1]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army (“the agencies”) published the “Revised Definition of ‘Waters of the United States,’” 88 FR 3004 (January 18, 2023) (“2023 Rule”). On September 8, 2023, the agencies published the “Revised Definition of ‘Waters of the United States’; Conforming”, which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) (“*Sackett*”).

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

- a. Wetlands W-2 and W-5 are not TNWs, territorial seas, or interstate waters and therefore are not (a)(1) waters. Topographic maps, Google Earth Pro aerial imagery, and site photos provided in the delineation report indicate that Wetland W-2 is confined within the review area and surrounded by an active agricultural field in all directions. The same data sources show Wetland W-5 is also confined within the review area and surrounded by uplands involving an active agricultural field to the south, east, and west, and uplands involving a forested area immediately to the north. Lidar data shows a ditch-like feature extending east to west approximately 40 feet north of Wetland W-5. However further review of other Lidar layers shows a topographic increase immediately north of the wetland, confirming this wetland transitions to uplands and is not hydrologically connected to the ditch-like feature further north. A review of aerial photos suggests swale-like features extending north and south outside of the boundaries of Wetland W-2. However, a review of Lidar data (3DEP Hillshade) and site level photos provided in the delineation report confirm these areas are upland and there is no hydrological connection between Wetland W-2 and other aquatic resources.

Based on the above information, Wetlands W-2 and W-5 do not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary and are not separated from a jurisdictional water by a natural berm, bank, dune, or similar natural landform. Therefore, Wetlands W-2 and W-5 are not jurisdictional under the 2023 Revised Definition of “Waters of the United States”: Conforming” 88 FR 61964 Final Rule.

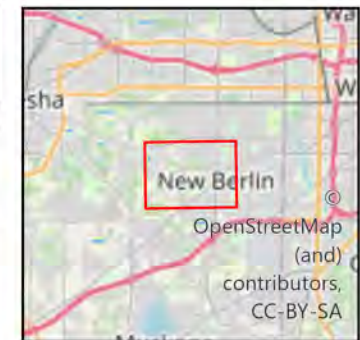

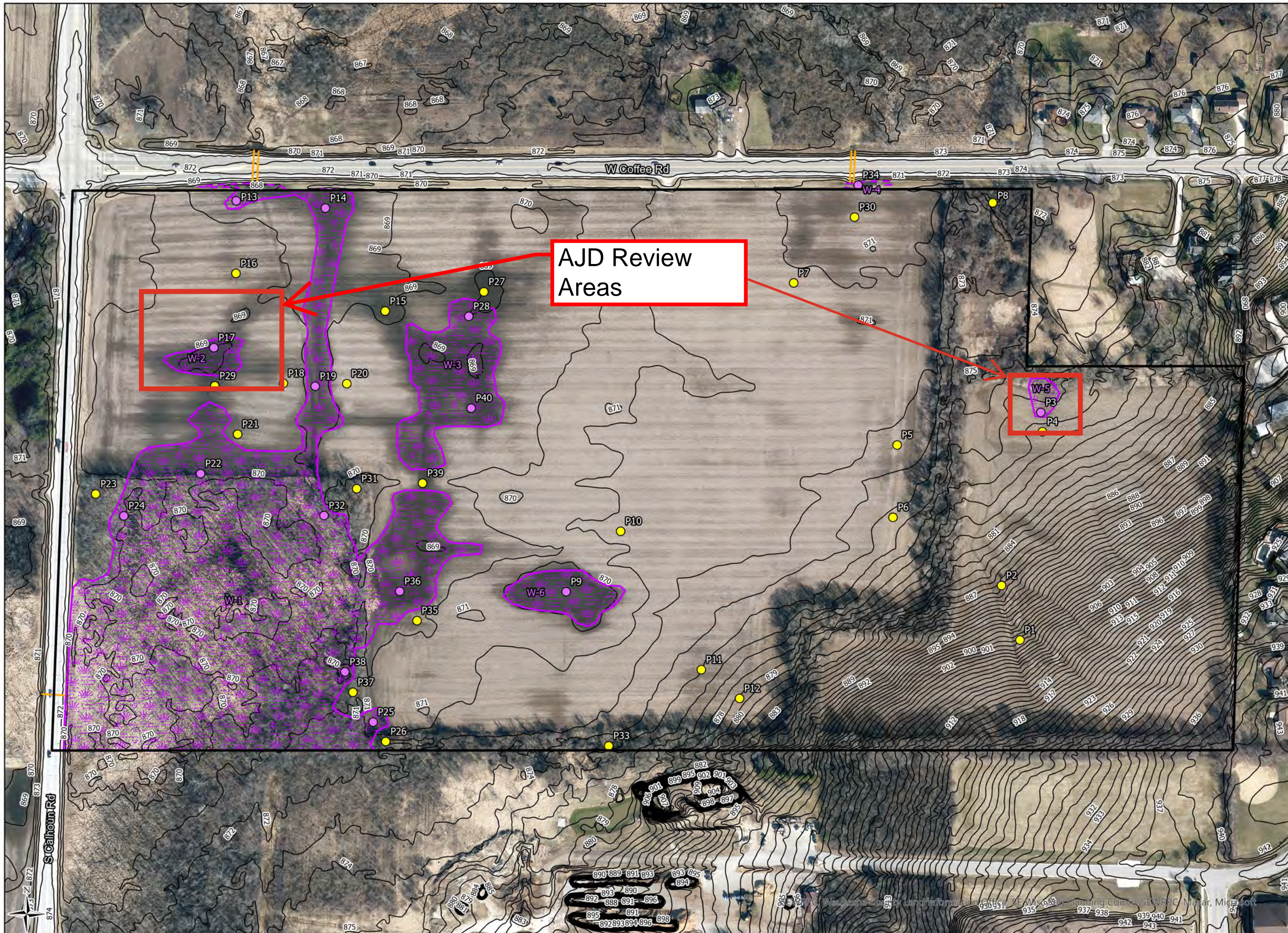

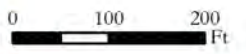
