MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the “Revised Definition of ‘Waters of the United States’”; (88 FR 3004 (January 18, 2023) as amended by the “Revised Definition of ‘Waters of the United States’; Conforming” (8 September 2023),¹ MVP-2025-01331-ALH [[MFR 2 of 2](#)]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army (“the agencies”) published the “Revised Definition of ‘Waters of the United States,’” 88 FR 3004 (January 18, 2023) (“2023 Rule”). On September 8, 2023, the agencies published the “Revised Definition of ‘Waters of the United States’; Conforming”, which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) (“*Sackett*”).

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

On April 1, 2026, a site visit was conducted to further evaluate Wetland 1 and Wetland 3. Wetlands 1 and 3 extend off site to the north toward Ashwaubenon Creek. There is a significant drop in elevation from where the wetlands are located to Ashwaubenon Creek. In between the delineated wetlands and Ashwaubenon Creek, there are two erosional features that do not have any evidence of an ordinary high-water mark, nor do they carry relatively permanent flow. These erosional features lack all wetland indicators and do not serve as a connection from Wetland 1 or 3 to Ashwaubenon Creek. The National Wetland Inventory layer on the National Regulatory Viewer does not indicate the presence of wetlands where these are located. The USA Soils Hydric Class layer shows non hydric soils or partially hydric (1-25%) soils where this wetland is located. Multiple years of aerial imagery have not shown many changes in the last decade. Therefore, these wetlands do not abut a relatively permanent jurisdictional water.

The wetlands are not TNWs, territorial seas, or interstate waters and therefore not (a)(1) waters. The wetlands do not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary. The wetlands are nontidal wetlands that do not abut a relatively permanent jurisdictional water and as such do not meet the definition of adjacent and cannot be evaluated as (a)(4) adjacent wetlands; therefore, the wetlands are not jurisdictional under the 2023 Revised Definition of 'Waters of the United States'; Conforming" 88 FR 61964 Final Rule.

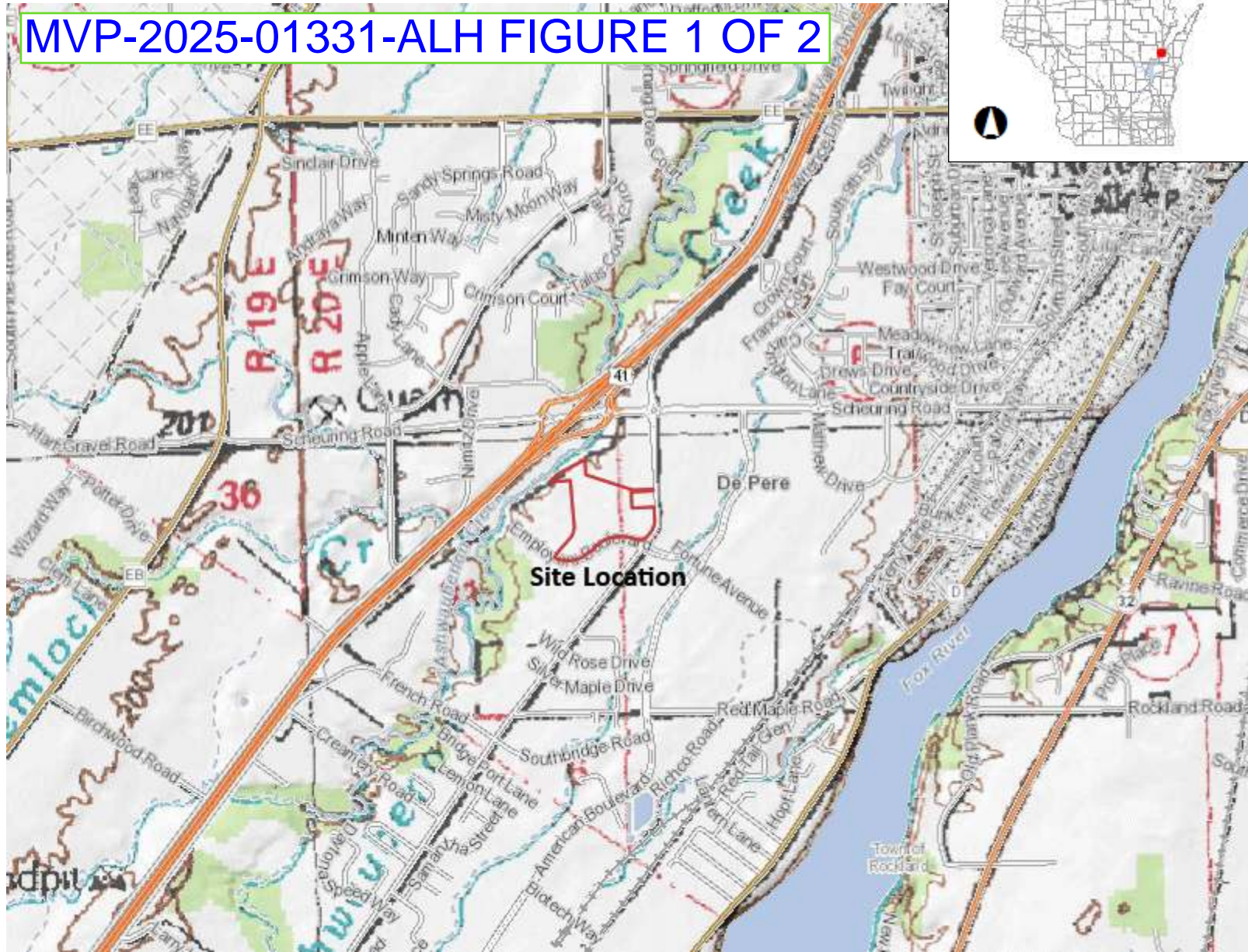

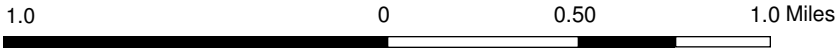


Figure 1 - Site Location Map
