CORPS CAMPGROUNDS OPEN

A sure sign that summer is upon us is the opening of the Corps' camping areas in Minnesota scheduled for 12 May.

Five Clear Writing Principles Chase Away Gobbledygook

Whether you are composing a letter or report, a Federal regulation, or the great American novel, there are five writing principles that will help you write clearly, accurately, and fast. And they will give your writing a warm yet dignified tone.

1. Prefer clear, familiar words. Never use a large word when you can say the same thing with a small one. (For example, say "use" instead of "utilize," or "enough" instead of "sufficient.") Small words produce clearer and more precise writing.

2. Keep most sentences short and simple. Your writing should average between 15 and 20 per words per sentence. (But mix them up; don't make ary sentence between 15 and 20 words.) Better to express a complex thought in several short sentences than in one long one. Your reports and letters may be harder to write-but easier to read. Your ideas will be harder hitting.

3. Prefer active voice verbs; avoid passives. Nothing makes writing more "blah" than the passive voice. Worse, it makes your style inaccurate because it fails to tell by whom. (Write: "Our engineers have estimated ..." rather than: "it has been estimated ..." or: "You must install the equipment ..." rather than: "The equipment must be installed ...")

4. Get people into your writing. Don't drag them in artifically, but don't try deliberately to make your writing impersonal. The "third person" style is hard to justify. Instead of saying: "This office should be duly notified upon receipt ..." why not say: "Please notify us when you receive ..." Yes, you may even call yourself, "I," but don't overdo it.

 Use a conversational style. Write it the way you would speak it. But caution: we tend to be careless in

Everyone has his own way of coping with the pressure of being on a flood fight team.

For Maurie Geiken, Message Center, changing his identity helped him cope. Maurie took on the identity of "Cowboy Bob" shortly after his arrival in Fargo. Complete with hat, western shirt, spurs, a bandana and even a "gun" and holster, Cowboy Bob kept the troops amused.

After Cowboy Bob was victimized in a minor hit and run accident with his rented LTD, Ol' Bessie, the following accident report was filed by Marsha McTamaney:

"...The time was 0700 hours on Thursday the 13th. It was cold outside with winds gusting up to 3 miles per hour, visibility was estimated at 59-1/2 feet by Cowboy Bob.

"He hitched Ol'Bessie to the hitching post the night before at the dude ranch, (Westward Ho), in what he considered to be the perfect angle...sideways.

"He was about to put the feeding bucket on Ol' Bessie when he noticed her rear_fender had been smashed in. Cowboy Bob was mortified. He thought at first that perhaps Ol' Bessie had been chasing around but then he realized she would never do such a thing to him, after all they meant so much to each other.

"So he went back to his room to regain his composure and he put on his spurs and left for work. He jumped on Ol' Bessie's back and kicked the spurs in deep, yelling, 'Come on, I know you can make it...I have got to get to work and report this accident.'

" So as weak as she was she gimped into work just so this accident report could be filed..."

While in North Dakota on flood duty. John Blackstone, ED-D, took his clothes to the laundromat in Crookston to have them washed. He left the bundle at the laundromat on Tuesday and they informed him it would be ready by Thursday. In the meantime, the crest prediction was changed in Crookston and he was sent to Grand Forks on Thursday. On his way to Beltrami on Friday, John stopped in Crookston to check on the status of his laundry and found that it had been sent to Fargo and it wouldn't be ready until at least 1 p.m. The Crookston laundromat called Fargo to have the clothes sent to the Grand Forks Air Base, but John had already left on the 3 p.m. flight to the Twin Cities.

When last heard of, the laundry was en route to the Twin Cities via a van driven by Dan Martin and Clyde Hanson.

John jokingly remarks he is sure Bill Spychalla and Martin McCleery have split up the clothes and are wearing them.

FLOOD FIGHT

From 13 March when the flood emergency office opened in Fargo, until 21 April when the office in Grand Forks closed, approximately 30 Corps employees were involved first hand in fighting the flooded Red River of the North

The crest at Fargo came on 2 April and was the 2nd highest on record, 4 feet less than the 1969 level. The flooding was worse than expected from Grand Forks to the Canadian Border which necessitated the opening of the Grand Forks office.

A main function of the Corps was to coordinate activities with local officials, Dave Christenson, office engineer, said. Guidelines had already been established and people back in the District Office helped answer questions concerning those guidelines, he said.

Most of the personnel involved were unfamiliar with the Red River area and flood fighting techniques; however Bill Spychalla, area engineer, said everyone worked well together and caught on quickly.

"The situation changed hourly and daily. Through it all, morale remained high and there were no personality conflicts," Bill said.

Dave also felt the morale of the Corps employees was good and said, "The people that were there wanted to be there and that helped considerably. It's not bad work, it's exciting and you're always doing something," he added.

New this year was extensive ground and aerial video tape coverage of the flooded areas and coverage of conferences and meetings held during the height of the crisis. These tapes are in the process of being compiled and made into summany tapes on various aspects of the flood.

Bill felt everyone was prepared for the flood, and while there is always something to learn through experience, the people involved did a "fantastic job."

Most of the people were back from North Dakota by 21 April.

The lateness of the 1965 season was because of extensive flooding, according to Dennis Erickson, head of the Lock and Dam section. In 1960, the season also began on 7 April, and the earliest tow to enter St. Paul was on 5 March 1976.

From The EEO Corner by Sharon Brown

Thanks to the support of many of you, significant progress has been made in EEO during the past 6 months.

Federal Women's program - In the FWP things are beginning to look up. More and more women are becoming concerned with selfimprovement and are taking advantage of the opportunities afforded them. For instance, at least ten women have recently identified goals and are taking outside extension or correspondence courses. They also received more in-house training this year than ever before. Women are presently occupying five of the eight upward mobility positions, and three women have been added to the DA career program in the Engineering and Scientist field. At the end of the calendar year, the total NCS workforce had decreased by 59 employees from the previous quarter, yet there was an increase of 6 women and 5 minorities. Of the 779 employees, there are 121 women in the District workforce. (For questions concerning the Federal Women's Program, contact Joanne Catherman, extension 7613.)

Hispanic and American Indian Programs -Val Burlingame, the Hispanic Employment Program Coordinator (formerly known as the SSPC), has been actively involved in strengthening the Hispanic and American Indian programs in the District. Authorized by the CSC to administer Civil Service exams, she participates in testing programs to try to get more Hispanics on the CSC register. She



Special Employment and Training Programs- We have 40 COOP students who will be graduating over the next 2 years; eight employees participating in the Upward Mobility program; and five students in the 16-hour, stay-in-school program. We also will become involved again this year in the summer youth employment program and will place three engineering and scientist students from the University of Minnesota in summer jobs.

Supervisors and Managers- We are getting feedback from employees that supervisors are giving them more effective performance evaluations, an area of great importance to both employees and supervisors. These evaluations provide an opportune time to discuss career goals and to motivate employees through direct encouragement and assistance. We've also had comments from managers and supervisors, such as "Will you help me develop an internal EEO Plan for my organization" and "Don't you think it would be beneficial to clerk typists to allow them to draft some routine letters, to allow them the chance to sharpen up on some letter writing skills." These seem like simple questions, but it shows there is increased concern.

Twenty-four field personnel from the Dredge Thompson, Dkbt Hauser, Locks and Dams & Fountain City Service Base attended a class in Fountain City on 30-31 March. The course, Effective Interpersonal Communications and EEO and the Supervisor, was taught by Robert Fjerstad of the Human Relations Consultants. The course has been taught a few times at the District Office and will be taught in May at Duluth.
