Wetland 1	0.01	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 1 was noted as a seasonally flooded basin that was unvegetated and did not contain any outlet by the wetland delineator. The wetland delineation report sampled adjacent upland points that did not contain hydric soil indicators. MnTOPO 2-foot contours were viewed as part of the desktop review show the area as largely being surrounded by upland. Due to the lack of a surface water connection to an a(1)-a(3) water, Wetland 1 is not considered a water of the U.S. under the Navigable Waters Protection Rule.
