Wetland 1	0.07	(b)(1) Non-adjacent wetland.	Based on a review of aerial photography, topographic maps, and the wetland delineation report submitted by the requestor, we have determined that these features are isolated wetland depressions with boundaries that transition into uplands. As evidenced on aerial imagery, the wetland signatures observed within the delineated wetland features do not extend outside of the limits of these wetlands and are surrounded entirely by uplands. In addition, the review area has minor changes in elevation, as shown on the USGS topo maps.
Wetland 2	0.17		Wetland 1 and Wetland 2 do not abut any a(1)-a(3) waters and are not separated from one by a natural or man-made feature. The nearest mapped tributary from the review area (Black Creek) is located 1,039 linear feet southwest of Wetland 1, with an elevation difference of approximately 8.98 feet, eliminating the likelihood of these features being flooded in a typical year by an a(1)-a(3) water. In addition, all wetland features within the review area are located outside of the FEMA mapped flood zone of Black Creek. Based on this information, we have determined that Wetland 1 and Wetland 2 are (b)(1) Non-adjacent wetlands, which are not regulated under Section 404 of the Clean Water Act.
