Watercourse (WC-01)	0.03 acre(s)	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	WC-01 is a swale feature measuring 126 linear feet. USGS Topographic Map, NHD, and NWI do not identify a water feature in the area of WC-01. However, the Wetland Delineation Report included site photos of the watercourse that showed vegetation absent, wracking, no surface water, and litter washed away. A review of 19 aerial photos from 2003 to 2020 showed no surface water in the area of WC-01, or up and down gradient of the feature. Considering the site photos showed evidence of physical characteristics of a water mark, but no surface water has been observed, WC-01 is determined to be an ephemeral feature.
