W-1	3.59	acre(s)	(b)(1) Non-adjacent wetland.	Based on elevation contours, W-1 contains no inlets/outlets other than overland sheet flow. The wetland is located within the 100-year floodplain of Spring Brook (an (a)(2) tributary) based on FEMA Flood Hazard Zones map, but based on aerial photographs and topography the wetland would not be flooded by Spring Brook in a typical year. Spring Brook's elevation near the culvert under the railroad is approximately 812' based on Rock County 2-foot contours, and the lowest extent of the delineated wetland occurs at approximately elevation 818'. The culvert is approximately 310 feet away from the W-1. Aerial photographs show evidence that the wetland can receive overflow runoff from the adjacent stormwater pond and that this runoff could flow northeast under the railroad culvert and into Spring Brook; however, flooding from W-1 to an (a)(2) tributary does not define W-1 as jurisdictional since the flooding would need to occur from the (a)(2) tributary to W-1 in a typical year. Additionally, there are no natural berms, banks, dunes, or similar natural features physically separating W-1 from an (a)(1)-(a)(3) water. Although there is a railroad between W-1 and Spring Brook, there is not a direct hydrological surface connection in a typical year (as described above), so W-1 is not physically separated from an (a)(1)-(a)(3) water by an artificial dike, barrier, or similar artificial structure.
Stormwater Pond	0.45	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	This feature is used to store stormwater runoff and was constructed sometime after 2010 in non-jurisdictional wetland (see W-1 discussion above).

<sup>5</sup> Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
