Wetland 1	0.81	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 1 is surrounded by higher elevations and located in a highly developed setting. Situated in a depressional area, it only receives hydrology during precipitation events. The nearest (a)(1)-(a)(3) water is Dutchman Creek located approximately 0.77 mile to the south. Wetland 1 is not separated from this creek by natural or man-made barriers. Additionally, the wetland is outside of the 100-year floodplain and does not receive flooding from Dutchman Creek in a typical year. A previous AJD was completed in August 2015 that determined Wetland 1 was isolated from all other aquatic resources. Conditions within the review area have remained relatively the same.
