SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no “*navigable waters of the U.S.*” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

B. CWA SECTION 404 DETERMINATION OF JURISDICTION.

There are no “*waters of the U.S.*” within Clean Water Act (CWA) jurisdiction (as defined by 33 CFR part 328) in the review area.

- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Identified Wetlands B, C-2, and CC do not have a surface or subsurface connection to a water of the United States. The Wetlands B, C-2, and CC are within a moderate depression with no outlets. The wetlands were determined to be geographically isolated. No surficial connections are present between these 3 wetlands and any other waters. Desktop resources such as aerial photography, LiDAR derived elevation models and contours, and stream and wetland, were reviewed and we determined that there are no surface or subsurface connections between these wetlands and other waters.**

Identified Wetland C also does not have a surface or subsurface connection to a water of the United States. Wetland C is also within a moderate depression. A gully formed between the Wetland C and Wetland D as a result of plowing activity and precipitation events. The soil was not stable where the gully formed (silty soil) and was determined to be a soil erosion feature in landscape. In addition, there is no inlet from Wetland C to the 12" drain tile that crosses the property. Therefore, the wetland is also not a water of the U.S.

Wetlands B (804 sq ft), C-2 (1,860 sq ft), CC (140 sq ft), and Wetland C (3,409 sq ft) do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. These wetlands do not have an ecological connection to other waters within or adjacent to the review area. The wetlands were determined to not be jurisdictional under the CWA because the wetlands lacked links to interstate commerce sufficient to serve as a basis for jurisdiction.
