Current and historical aerial photographs included in the delineation report showed no wetland signatures in the review area. In a Notice of Decision dated 4/8/2021, the TEP concurred with the delineation report that there were no wetlands on site. Based on the above information, the Corps has determined that there are no jurisdictional waters of the US (WOUS) in accordance with the NWPR.
