Explain: **The review area for this jurisdictional determination includes two roadside ditches labeled as Wet Ditch 1 and Wet Ditch 3 on the attached figures labeled 2018-03076-BGO AJD Attachments, Pages 1-4 of 4. The total area of non-jurisdictional waters/features is approximately 0.08 acre.**

The roadside ditches were constructed in uplands to convey runoff from the adjacent roadway, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WoUS). This was confirmed by reviewing aerial photography, hydric soils, and national wetland and hydrography data provided in the delineation report. Per the Rapanos decision, the assessed ditches are not WoUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters.
