North of the wetland. Topo maps show no single natural feature separating the wetlands from this tributary.</p> <p>There is no mapped floodplain for the nearest tributary. The elevation change (over 20 ft) and the distance from the tributary supports that it would not flood Wetland 1 in a typical year. Other tributaries in the surrounding area do have mapped floodplains that do not extend to Wetland 1.</p>
