Explain: **The review area contains seven wetlands: Wetland B (0.02 acre), Wetland C (0.18 acre), Wetland D (0.04 acre), Wetland E (0.02 acre), Wetland F (0.02 acre), Wetland G (0.03 acre), and Wetland H (0.10 acre). These wetlands are located in topographic depressions created in dry land due to on-site grading, topsoil stripping, and excavation associated with the development and operation of a tree nursery, as shown by aerial photographs documenting the construction and continued use of the tree nursery from 2000-2018. Wetlands B-G were constructed in non-hydric soils. Wetland H was constructed in hydric soil but based on aerial photos (2000) and elevation contours the area was not wetland before construction of the nursery. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following activities to be waters of the United States; water filled depressions created in dry land incidental to construction activity.**
