The review area contains one intrastate wetland (Wetland 3) that according to the Wrenwood Development Site Wetland Delineation Report dated October 4, 2017 by Stantec Consulting Services is an isolated wetland basin.

This wetland is surrounded by uplands and does not have a direct hydrologic surface connection to downstream waters. This was confirmed by reviewing the supporting information in III(A) below. The nearest waterway is the Menomonee River approximately 2 miles to the west, soils maps show the area to be non-hydric soils, the WWI map does not include this area as wetland, and aerial imagery shows the areas surrounded by an upland farm field with no wetland hydrology or vegetation signatures connecting the wetlands to downstream jurisdictional waters. They are not separated from other WOUS by man-made dikes, barriers, or berms. The surrounding landuse is a mixture of residential development and agriculture. The residential development disturbance surrounding this wetland precludes an ecological connection to a WOUS.

This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetland 3, as shown on attached figures, is not regulated by the Corps under Section 404 of the Clean Water Act.
