The wetland ditch portion of Wetland 6, Wetland 21 and Wetland 23 were not constructed in wetland and the wetlands delineated within these features are not adjacent (a)(4) waters. These wetland ditches were constructed in upland areas to convey run-off from the adjacent roadway; they are now linear wetlands. Topography and Lidar maps provided for the project indicate that these roadside ditches have a distinct backslope above the ditch bottom, and the hydric soil and national wetland inventory maps for the project corridor indicate that these roadside ditches were constructed in non-wetland areas. The wetland ditch portion of Wetland 6, Wetland 21 and Wetland 23 are not (a)(1) waters, they were not constructed in a tributary, do not relocate a tributary, and were not constructed in an adjacent wetland. The wetlands delineated within these features are not adjacent (a)(4) waters.
