Wetland 1A	.168	acre(s)	(b)(1) Non-adjacent wetland.	Wetland does not abut an a(1)-(3) water nor is it inundated by flooding from an a(1)-(3) water in a typical year. Wetland is not separated from an a(1)-(3) water from by a natural or artificial feature nor does it have direct hydrological surface connection in a typical year. Lake Winnebago is approximately 5,500 feet SW of the wetland, the nearest tributary to Lake Winnebago (WBIC 5022360) is approximately 1,700 feet south and is separated by at least 35 feet of elevation change.  The flood hazard zones are mapped for Lake Winnebago and the review area is not near the zones, flood zones do not appear to be mapped for the unnamed tributary to the south but it is not possible it would flood the wetland in a typical year based on the distance and elevation between the features.  Wetland 1A continues off the review area to the SW to abut a manmade ditch. Historical Aerial photos from 1977 do not show wetness signatures before excavation and development in the area.
