W1 W2 W3	1.59 0.86 0.11	acre(s)	(b)(1) Non-adjacent wetland.	These features are shallow open water depressions surrounded by upland. The soils surrounding the wetlands are predominantly non-hydric. The closest jurisdictional aquatic resource to either of the three wetlands is Lake Minnetonka, approximately 600 feet to the NE. W1 is about 8 feet higher in elevation than the lake (934' to 926'), while W2 and W3 are about 20 feet higher (946'). There are no culverts or other conveyance features connecting the wetlands to Lake Minnetonka. W2 extends south outside of the review area to a larger wetland; however, this wetland was reviewed and is not adjacent to an (a)(1)-(a)(3) water. These features would not be flooded by an (a)(1)-(a)(3) water in a typical year. There are no natural berms, banks, dunes, or similar natural features physically separating them from a paragraph (a)(1)-(a)(3) water, nor are they physically separated from one by an artificial barrier.
