Wetlands 1 and 2	Total = 0.33	acre(s)	(b)(1) Non-adjacent wetland.	Wetlands 1 and 2 are surrounded by upland, as shown on the Existing Conditions Figure within the Wetland Permit Application. Wetland 2 extends offsite to the north of the project boundary. Review of Google Earth aerial imagery (April 2020, April 2018, April 2017, March 2016) shows the wetland features but does not show a connection to an a(1)-a(3) water. The National Hydrography Dataset (NHD) was also reviewed and did not show the wetlands having a surface water connection to an a(1)-a(3) water. Based on this information, Wetlands 1 and 2 are not waters of the U.S. under the Navigable Waters Protection Rule (NWPR).
