Explain: **The review area for this determination is limited to the boundaries of 38 roadside ditches labeled as Wetland I and Wet Ditch #1-37, on the attached figures labeled MVP-2019-02607-GLH / SAP 052-615-025 / CSAH 15 GP & AJD Attachments, Pages 1-8 of 8. The total area of non-jurisdictional waters within the review area is approximately 0.99 acre.**

**The roadside ditches were constructed in uplands to convey runoff from the adjacent roadway, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WOUS). This was confirmed by reviewing aerial photography, national hydrography data, LIDAR topography imagery, and the wetland delineation report. Per the Rapanos decision, the evaluated ditch is not WOUS because it is not a tributary and do not have a significant nexus to traditionally navigable waters.**
