Wetland 1	0.52	acre(s)	(b)(1) Non-adjacent wetland.	<p>Wetland 1 is an isolated wetland basin located in a depressional area at the southwest corner of the Trunk Highway (TH) 371 and Green Gables road intersection. The wetland is surrounded by uplands and does not have a direct hydrologic surface connection to downstream waters.</p> <p>This was documented in the delineation that was completed for the project site and confirmed by reviewing the enclosed national wetland inventory and topographic mapping for the project site. The assessed wetland does not abut jurisdictional waters, is not inundated by flooding from a traditional navigable water, or tributary, or from a jurisdictional lake, pond, or impoundment, and is not physically separated from a jurisdictional water by only a natural feature or artificial structure that allows for a direct hydrologic surface connection. Based on this review, the assessed wetland is not jurisdictional under the Navigable Waters Protection Rule (NWPR) because it meets the requirements of the exclusion for non-adjacent wetlands under paragraph (b)(1).</p>
Linear Ditch 1-6	1.75	acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	<p>Linear Ditch 1-6 were constructed in uplands to convey runoff from TH 371 and are now linear wetlands that meet the definition of “ditch” under paragraph (c)(2). In addition, the ditches are not (a)(1) waters, are not relocated tributaries, are not constructed in a tributary, and are not constructed in an adjacent wetland. This was confirmed by reviewing aerial photography, national wetland and hydrography data, and the wetland delineation report. Based on this review, the assessed ditches are not jurisdictional under the NWPR because they meet the requirements of the exclusion for ditches under paragraph (b)(5).</p>
