Contour maps, submitted by the applicant, show that Wetland A is situated in a depressional area that is completely surrounded by upland areas comprised of agricultural, commercial and residential properties, and multiple paved roads. Aerial imagery from Google Earth and the submitted Wetland Delineation Report confirm that Wetland A is not abutting an a(1)-a(3) water. Therefore, Wetland A is not considered a water of the U.S. under the Navigable Waters Protection Rule.
