The pond has steep slopes and two culverts installed in the south slope. The pond was not present in an aerial photo taken in 1957. The pond is located in an area mapped by the Scott County Soil Survey as Sartell fine sand (0% hydric). The MN DNR Public Water Inventory map does not identify any water bodies or courses and the USGS Topographic Map does not identify any wetlands or tributaries in the project area.
