Based on the U.S. Geological Survey, Ozaukee County GIS 2-foot elevation contours and FEMA map, these wetlands would not be flooded by an (a)(1)-(3) water in a typical year. There is no natural berm, bank, dune, or similar artificial structure physically separating these wetlands from an (a)(1)-(3) water.
