Wetland_5	0.12 acres	(b)(1) Non-adjacent wetland	The nearest (a)(1) - (a)(3) water is Coon Creek approximately 56 feet to the southeast. USACE had previously reviewed the boundaries of Wetland_5 from the delineation report, concurred that they were accurately identified, and sent a concurrence letter on November 20, 2020. The delineation report shows that Wetland_5 is entirely surrounded by uplands and has no surface water connection to Coon Creek. The delineation report has two upland sample points between Wetland_5 and Coon Creek with no hydrophytic vegetation, hydric soil, or indicators of wetland hydrology present. Wetland_5 fits the definition of a non-adjacent wetland under the NWPR and is not a water of the US (WOUS).
