**C.** Additional comments to support AJD: The review are for this determination is limited to the delineated boundaries of 2 Wetland areas labeled as Wetland(s) 11 and the roadside ditch portion on the western end of Wetland 13 on the attached figures labeled 2020-01710-CCK AJD Attachments, Pages 1-6 of 6. The total area of non-jurisdictional waters within the review area is approximately 0.1084 acres.

All of the wetlands within the review area meet the definition of "wetlands" under paragraph (c)(16) and are not (a)(4) waters because they do not meet the definition of "adjacent wetlands" under paragraph (c)(1). Wetland areas 11 and the roadside ditch portion on the western end of Wetland 13 were constructed in uplands to convey runoff form the adjacent roadway, and are now linear wetlands that meet the definition of "ditch" under paragraph (c)(2). In addition, the ditches are not (a)(1) waters, are not relocated tributaries, are not constructed in a tributary, and are not constructed in an adjacent wetland. This was confirmed by reviewing aerial photography, national hydrography data, and topographic data. Based on this review, the assessed ditches are not jurisdictional under the Navigable Waters Protection Rule because they meet the requirements of the exclusion for ditches under paragraph (b)(5).
