Pond 1	.09	acre(s)	(b)(1) Non-adjacent wetland.	The nearest a(2) water is Judicial Ditch 8, approximately 0.68 mile to the north of Pond 1 separated by residential homes and agricultural land. The pond is mapped on the National Wetland Inventory, McLeod County GIS interactive map, and is present in historic aerial imagery from 1937. The soil is mapped as Canisteo-Glencoe complex, 0 to 2 percent slopes, which is categorized as very poorly drained. Desktop review utilizing historic aerial imagery, current aerial imagery, National Hydrography Dataset information, and USGS topographic maps confirm that there is no surface water connection to an a(1)-a(3) water. Therefore, Pond 1 is not a water of the U.S. under the Navigable Waters Protection Rule.
