Wetlands 1 & 11	0.34	acre(s)	(b)(1) Non-adjacent wetland.	Wetlands 1 & 11 are physically separated from potential downstream (a)(1)-(a)(3) waters. They are not inundated by flooding by an (a)(1)-(a)(3) water in a typical year, and they are not physically separated from an (a)(1)-(a)(3) water by an artificial dike, barrier, or similar artificial structure that would allow for a direct hydrologic surface connection between the waterbodies and any potential downstream (a)(1)-(a)(3) waters, in a typical year. Wetlands 1 & 11 are hydrologically isolated and physically remote and do not qualify as (a)(1)-(a)(4) waters. This was confirmed by reviewing the wetland delineation that was completed for the project corridor, Lidar imagery, the National Hydrography Dataset (NHD), historic and current aerial imagery, and National Wetland Inventory (NWI) and Stearns County soil mapping for the project site.
