Wetland A is in a small pocket of trees. Wetland B is surrounded by a grassed, mowed lawn. Based on topographic contours, the only inlets/outlets are from overland sheet flow. They would not be flooded by an (a)(1)-(3) water in a typical year. There is not a natural berm, bank, dune, or similar natural feature physically separating them from a paragraph (a)(1)-(3) water. They are not physically separated from a paragraph (a)(1)-(3) by an artificial dike, barrier, or similar artificial structure.
