- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: According to the delineation report, two locations on the property were sampled for wetland potential. Hydrophytic vegetation was not found and neither area met indicators for hydrology or hydric soil. Representatives from BWSR and RCWD attended a site visit on 10/2/2020 and approved the finding of no wetlands at the site.
