Wetland A	0.25	acre(s)	(b)(1) Non-adjacent wetland.	The wetland is in a low mowed basin that pools water surrounded by upland. A two-lane road separates the wetland from Golden Lake. Based on the delineation report's description and Google Earth Street View images, there are no culverts on the road or any other feature that would allow for a direct hydrologic connection to Golden Lake. The GIS contours show that there are no inlet/outlets associated with the wetland other than overland sheet flow and that the wetland would not be flooded by an (a)(1)-(3) water in a typical year. There is not a natural berm, bank, dune, or similar natural feature physically separating the wetland from a paragraph (a)(1)-(3) water.
