Wetland 6	0.35	acre(s)	(b)(1) Non-adjacent wetland.	Wetland does not abut an a(1)-(3) water nor is it inundated by flooding from an a(1)-(3) water in a typical year. Wetland is not separated from an a(1)-(3) water by a natural or artificial feature nor does it have direct hydrological surface connection in a typical year. The wetland is completely surrounded by upland. Surface Water Data Viewer and National Wetlands Inventory maps show an unnamed tributary east of the permit area. Aerial photos show a tributary approximately 1,000 feet east of the review area. There is an elevation change of about 40-50 feet between the wetland and nearest tributary. A FEMA flood zone is mapped for the closest tributary, the nearest area within a flood zone is over 3,000 feet to the east. The distance and elevation change between the wetland and nearest a(1)-(3) water eliminate the possibility of the a(1)-(3) water flooding the wetland. Other features on the property (outside of the review area) have previously found to be non-jurisdictional on 10/23/2020 and 2/25/2021
