- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The review area consists entirely of cultivated field and is surrounded by row crop agriculture. The report submitted by Westwood Professional Services on behalf of the applicant supports the review area is entirely upland. NWI and NHD maps submitted by Westwood showed no mapped aquatic resources in the review area. A desktop review revealed wetness signatures in two portions of the site which were investigated by Westwood in the field. The data sheets included in the report support these areas do not meet wetland criteria. Therefore, there are no waters of U.S. within the review area.
