Aerial imagery from Google Earth indicates that the wetland is not abutting an a(1)-a(3) water and that there is no channelized surface water connection from Wetland A to an a(1)-a(3) water. Therefore, Wetland A is not considered a water of the U.S. under the Navigable Waters Protection Rule.
