C. Additional comments to support AJD: Wetland WB-01 is a constructed stormwater pond and is associated with the construction of the 65th Street road improvements. WB-01 is depicted as stormwater pond in the 2002 CSAH 13 Improvements grading plan; there is an street intersection near CSAH 13 and 65th Street. WB-01 is a stormwater control feature constructed or excavated in upland to convey, treat, infiltrate, or store stormwater run-off.
